### 5.1 Background

Within the Province of Ontario, the delivery of fire protection services is guided by the Fire Protection & Prevention Act (FPPA), including the strategic optimization of the three lines of defense, which include:

• Line one: Public fire safety education

• Line two: Fire safety standards and enforcement

• Line three: Emergency response

For these reasons, these Community Park Programs meet all three lines of defense, as our Fire Prevention staff is on scene to provide valuable fire safety education. They will also be providing, along with MLELS staff and other City Branches, information on fire safety standards, code requirements, tenant safety and upcoming enforcement projects like building audits. Lastly, we will have a fire crew on scene with their apparatus, which is the third line of defense. This program has provided value to the community in the past and will continue to do so. Staff will be providing handouts on fire and tenant safety, as well as freezies, for those in attendance.

The locations of the parks chosen this year were determined by our continued focus on multi-unit residential safety. Ward Two contains the Residential Rental Housing Licensing (RRHL) area and Wards Three and Four have a high rate of two-unit registrations and are areas we have not yet visited for this program.
