Subject: Oshawa History and Tourism

I have recently learned that you are looking to remove the beautiful mural of Northern Dancer in the City of Oshawa, and I strongly object to this decision. Sixty years ago, Northern Dancer put Canada and Oshawa area on the map by being the first Canadian-bred horse to win the Kentucky Derby, news of which you are likely familiar. What you may not know is that his name has left a lasting impact on equestrians, the racing industry, and horse enthusiasts alike. Growing up on the prairies and in the horse world, I always knew his name, but there was additional pride by anyone who had a horse with Northern Dancer in their pedigree. It didn't matter if it was as a sire, grandsire or great grandsire, his name has always carried tremendous weight, and still does.

In 2008, I had the privilege of touring Windfields Farm, visiting the stallion barn with horses present, and seeing the grave of Northern Dancer. I spent hours there in awe at this rich horse history. I am forever grateful that my cousins from the area took me there on a tour prior to the farm being closed to the public. I understand that development is necessary, but so is history. The fact that this has not been promoted and turned into a tourist destination by the City of Oshawa is a heartbreaking and missed opportunity.

If this happened in Europe, the farm would be part of tourism. You could have accommodations on site or at least charge to visit these historic buildings, including an on-site museum. There are many people who worked at Windfields Farm who could be great resources of knowledge or offer first-hand experience of working with these legends. I understand there are plaques honoring the history and that Doors Open Oshawa has one day per year that it can be visited, but this year was the first year the public could visit the grave of Northern Dancer in ten years. I do not understand why this hasn't been embraced, as people would come to tour. I strongly encourage you to look up the Irish National Stud Farm (https://irishnationalstud.ie/) to give you an idea of how the horse industry there has embraced tourism. While it has continued as a working farm, perhaps this could give you some ideas of how Windfields Farm could be better utilized and financially supported by tourism. This would also mean more tourism for the City of Oshawa.

To add to that experience could be a visit to the very mural that you are considering removing. At this time, this mural is one of the few publicly accessible places that Northern Dancer is promoted in the City of Oshawa, unless I'm mistaken. I had to specifically search on your website for Northern Dancer, rather than have it as a proud connection to your area, especially with this being a milestone year (60th since winning the Derby, Preakness, and Queen's Plate). He was also inducted into the National Museum of Racing's Hall of Fame in both Canada and the United States in 1976. Considering many people connected to Windfields are still alive at this time, there are plenty of resources that may not be there in the future and I encourage you to embrace what you can, while you can. Please do not destroy a beautiful piece of artwork, particularly one that highlights the history of Oshawa and area, by a horse that not only won historical horse races and sired generations of horses, but one who was valuable enough to be included in a Canada Post stamp and books all over the world.

I strongly urge you to reconsider and keep this mural, along with embracing the rich and beautiful history that you have before you. I would certainly return to see it, as I know of many others who would join in that too.
