Comments/Feedback on Development Applications and City Projects

By year-end 2024, O.E.A.C. reviewed and provided comments/feedback to City staff on the following development applications and City projects:

- O.E.A.C. held their annual tree giveaway event. A total of 310 trees were distributed for free to Oshawa residents.
- O.E.A.C. hosted a Fall Film Night at the Regent Theatre, in partnership with the DTO and Ontario Tech University. This event was free to the public and had multiple environmentally focused display booth vendors and featured a free screening of the documentary film "There's Something in the Water" to educate the public on environmental initiatives. Approximately 100 people attended the event. Food donations were collected in lieu of an entrance fee and donated to a local Oshawa food bank.
