1.0 Purpose

The purpose of this report is to recognize Fire Prevention Week and highlight public engagement initiatives from October 5-11, 2025 to raise fire safety awareness.

4.0 Analysis

4.1 Background

On October 8, 1871, the Great Chicago Fire occurred resulting in over 250 fatalities, leaving 100,000 people homeless, destroying 17,400 structures and 2,000 acres land burned. Fire Prevention Week was first established in 1925 and declared as a national observance dedicated to fire safety and prevention by President Calvin Coolidge. This observance highlights the importance of public education and the proactive measures that can be taken to prevent fire-related casualties and property loss. Public education is at the forefront of Fire Prevention week and targets all age groups, from children to seniors ensuring everyone understands the role they play in fire prevention and reinforcing the importance of fire safety.

4.2 Fire Prevention Week

The purpose of Fire Prevention Week is to educate residents on the importance of fire safety and best practices, empowering everyone to protect themselves and their community. The theme for 2025, "Charge into Fire Safety: Lithium-Ion Batteries in Your Home," highlights the critical need to safely buy, charge, and recycle lithium-ion batteries to prevent fire hazards.

During Fire Prevention Week, Oshawa Fire Services will engage the public through various activities aimed at increasing awareness and understanding of fire safety. Oshawa Fire Services staff will be present at the following locations:

- Tribute Communities Centre Oshawa Generals game on Sunday, October 5.
- McDonalds –501 Ritson Road South Coffee with the Crews on Friday October 10 -10 a.m. to 12:00 p.m.
- North End Bowl Fun World- Saturday, October 11 10 a.m. to 2:00 p.m.

At each location, the Fire Prevention Division of Oshawa Fire Services will set up an educational booth featuring demonstrations, displays of smoke and carbon monoxide alarms, and a variety of giveaways. Educational handouts will also be provided in collaboration with the Fire Marshal's Public Fire Safety Council. These efforts aim to equip residents with the knowledge and tools needed to ensure that their smoke alarms are functioning correctly and that they are prepared in the event of a fire.

Fire Prevention Week serves as a critical reminder of the importance of fire safety and the collective responsibility we all share in protecting our homes, families, and communities from the dangers of fire. By engaging with the public during this week, Oshawa Fire Services reaffirms its commitment to reducing fire risks and enhancing the safety of all residents.
