Subject: Neighborhood Safety Concerns on Esterbrook Dr

Hello,

I am writing to plead for support from the city regarding the traffic safety on my street, Esterbrook Dr.

In the past 6 years there have been 2 major accidents for a suburb street for which the speed limit should be no higher than 25km/hr. The accident had a van lose control and end up on its roof. The second happened last summer including about 3 vehicles, 2 parked and a tree that got side swiped. In either incident, if anybody was walking with their children or kids were riding their bikes in the area of these accidents, there would be a high likelihood for a fatality.

I have spoken with the police officer that completed the report last Aug, emailed 2 other police officers directly and escalated my concerns to the previous city councillors for my ward and in 6 years absolutely not 1 reply or show of concern. Yet, still to this very day drivers use this road as a drag strip to reach the end of the street (to either continue North on Esterbrook around the bend or reach the stop sign at Grandview). Without a speed radar, I would ascertain many cars myself and neighbours have witnessed are driving in excess of 50-60km/hr!

I am hoping with new councillors in my ward that the voices of residents like myself will be heard and the city will take action BEFORE a life is actually lost, at which time it will be too late!

Attached are pictures I took of the incidents. Unfortunately I did not get many pictures from the second incident as the officer was actively conducting his investigation and completing his report and did not wish to interfere. But there should be reports based on the dates and the officer can be identified from the picture.


Additionally, after speaking with several of my neighbors about these concerns, 2 more additional concerns have been raised.

Drivers are not stopping at the stop sign at Harlstone and Esterbrook and regularly rolling through at 20-30km speeds to make their right hand turn onto Esterbrook


